#### AWARDS AND REWARDS

##### 1. Participation and Remembrance

- Each participant receives a **small souvenir** of the event.
- A **certificate of participation** will be available for **download**.

##### 2. Individual competitions - medal standings

- All competitions are scored according to the **DSV Masters points table**, **regardless of age group**.
- The **top three finishers in each competition** receive medals.
- The current German Masters record list can be viewed at: <https://www.dsv.de/de/leistungs-und-wettkampfsport/masterssport/schwimmen/rekorde/> (as of 05.09.2025).

##### 3. Best individual performance

- The female and male swimmers with the **best individual performance** according to the DSV Masters points table will each receive a prize.

##### 4. Power Cup

- A "Power Cup" is awarded to swimmers who **successfully participate in at least 14 individual competitions**.

##### 5. Team ranking

- The relay races are scored **according to time points across all age groups**.
- The **top three finishers** will receive trophies.
- The scoring is based on the current **German Masters swimming records** (25m pool), available at: <https://www.dsv.de/de/leistungs-und-wettkampfsport/masterssport/schwimmen/rekorde/> (as of September 5, 2025).  
Example : A **relay** team achieves 1,000 points in competition 7 in the 120 age group with a time of 1:48.77 and in the 320 age group with a time of **3 : 26.84**.

##### 6. Funding Cup (WK 27 – 4 x 50 m medley mixed)

- The "Fördepokal" is awarded to the winning relay team of the **oldest age group** in WK 27 (4 x 50 m Medley Mixed).
- The winning team is responsible for **engraving** the trophy and brings it to the **next event**.
- If the participant does not take part in the following year, the trophy must be sent to the **Flensburg Swimming Club in good time**.

##### 7. Awards ceremony

- The award ceremonies take place **continuously throughout the event and finally before the "Plop Relay"**.
- The awards ceremony **is an integral part of the event**. Swimmers who **do not** attend the ceremony **forfeit** their right to their award. Trophies and medals will **not be sent out**.

#### GENERAL TERMS AND CONDITIONS

##### 1. Legal provisions

competition regulations (WB), the legal code (RO), the competition license regulations (WLO), the competition fee regulations (WGO) and the anti-doping regulations (ADO) of the German Swimming Federation (DSV) apply in their respective valid versions. For people with disabilities With appropriate classification documentation, the rules of the IPC apply in addition to the competition rules of the German Disabled Sports Association (DBS). Official medication documentation in accordance with anti-doping regulations must be available. A valid medical certificate, possibly with a therapeutic use exemption (TUE), must be presented.

All active members of clubs, departments, and joint teams affiliated with the DSV (German Swimming Federation) or WORLD AQUATICS are eligible to participate. The event is sanctioned by the SHSV (Schleswig-Holstein Swimming Association) and displayed to the DSV.

##### 2. Licenses and sports health

By submitting the registration, the clubs and joint teams confirm that the swimmers they have registered:

- have the **right to start for the club / starting community**,
- the **required annual license according to § 19 WB (AT)** for German swimmers has been paid,
- their **fitness for sport by means of a medical certificate** that is not older than **one year** (§ 11 (2) WB-General Part).

The Flensburg Swimming Club of 1930 eV accepts **no liability** if it turns out that the athlete is not in **good health** or does not have a valid annual license.

#### 3. Swimwear

WORLD AQUATICS regulations and the corresponding DSV guidelines on swimwear apply . Visual inspections of the swimwear are carried out before the start .

#### 4. Starting rules and timing

The one-start rule applies to all competitions. Electronic timing is used .

#### 5. Referees

The smooth running of the competition is only possible with the support of all clubs. Please register enough referees so that we can conduct the event as planned. Should the number of registered referees be insufficient, the entries of individual clubs may be cancelled.

Each participating club must provide referees who hold a valid referee license for their respective task . The final number of referees required will be announced in the registration results.

The names of the referees must be submitted by email to [meldungen@flensburger-schwimmklub.de](mailto:meldungen@flensburger-schwimmklub.de) by 12:00 PM on February 15, 2026, to transmit.

Referees in training should also register with the organizer by 12:00 PM on February 15, 2026. The event referee(s) will decide on their acceptance in the order of registration.

#### 6. Reports and data protection

By submitting the entries, the club / joint team acknowledges the announcement and declares that it has received a data protection declaration from every person involved in the event (athletes, coaches, referees and helpers) – in the case of minors, from their legal guardians .

organizer and promoter is permitted to:

1. To collect, store, process, and publish competition-relevant personal data of the aforementioned group of people in entry lists, competition protocols, and rankings – also within the context of reporting on the event . This data may be forwarded to the SHSV (Schleswig-Holstein Swimming Association) and the DSV ( German Swimming Federation ) . The entry list, protocol, and rankings will be published online (e.g., on the websites of the organizer, the SHSV, and the DSV ).
2. To publish competition-relevant personal data as well as photos, film recordings or photomechanical reproductions of the participants and to forward them to the organizer, SHSV, DSV and to third parties (media, social networks, sponsors).
3. The entire competition may be broadcast via live stream on the internet.

**Data collected includes:** name, first name, gender, year of birth, performance achieved (placement, time achieved and points score), any disqualifications with justification and, if applicable, ENM, club affiliation and, for referees, the position of assignment.

Entries must be submitted on the DSV entry form (DSV form 101) and DSV entry list (DSV form 102) with the following information:

- Active ID number
- Year of birth & age group
- Club ID & ID of the state swimming association

When registering for relay events, it is essential to specify the competition classes and the names of the relay swimmers .

- The names of the relay swimmers can be changed on the day of the competition, but the ranking classes cannot.

Reports must be submitted via email as a file conforming to the DSV or LENEX standard . Other file formats or handwritten reports cannot be processed .

#### SPECIAL CONDITIONS

##### 1. Registration fee

The registration fee is:

- €8 for one-way trips
- €85 for participants in the "Power Cup" (for 14 or more starts, the corrected entry fee will be shown in the registration confirmation)
- 11 € for tiers

Competitions are seeded according to entry times, regardless of age group .
