14th edition of the Flensburg "Plop Relay"

Age groups are divided in accordance with § 152 of the Swimming Competition Rules – Masters (FT SW MS).

Swimmers born between 2007 and 2016 are eligible to compete in the KSV Flensburg children's and youth competition, provided they belong to a club affiliated with the KSV.

International age group classifications apply to relay competitions. Swimmers in the AK20 age group are not eligible to compete.

A 25-metre warm-up and cool-down pool will be available to competitors throughout the event.

AWARDS AND PRIZES

1. **Participation and souvenir**
 - Each participant will receive a **small souvenir gift** from the event.
 - A **certificate of participation** will be available for **download**.
 - The KSV Flensburg children's and youth competition is **open to all**; there will be **no award ceremonies**.
2. **Individual competitions – medal scoring**
 - All competitions are scored across age groups according to the **DSV Masters points table**.
 - The **top three finishers in each competition** will receive medals.
 - The current German Masters record list can be viewed at: <https://www.dsv.de/de/leistungs-und-wettkampf-sport/masterssport/schwimmen/rekorde/> (as of 05.09.2025).
3. **Best individual performance**
 - The swimmer with the **best individual performance** according to the DSV Masters points table will receive a prize.
4. **Power Cup**
 - A "Power Cup" will be awarded to swimmers who **successfully participate in at least 14 individual competitions**.
5. **Relay ranking**
 - The relay competitions are scored **across age groups according to times**.
 - The **first three places** receive trophies.
 - The scoring is based on the current **German records for Masters swimmers** (25-metre pool), available at: <https://www.dsv.de/de/leistungs-und-wettkampfsport/masterssport/schwimmen/rekorde/> (as of 5 September 2025). *Example:* A relay team achieves 1,000 points in WK 7 in the AK 120 with 1:48.77 and in the AK 320 with 3:26.84.
6. **Fördepokal (heat 27 – 4 x 50 m mixed medley)**
 - The "Fördepokal" is awarded to the winning relay team in the **oldest age group** in WK 27 (4 x 50 m medley mixed).
 - The winning relay team is responsible for **engraving** the cup and bringing it to the **next event**.
 - If you do not participate the following year, the trophy must be returned to the **Flensburg Swimming Club** in good time.
7. **Award ceremonies**
 - The award ceremonies will take place **continuously during the event** and **finally before the "Plop Relay"**.
 - The award ceremonies are **part of the event**. Swimmers who do not attend the ceremony **forfeit** their right to their award. Cups and medals will **not be sent on**.

GENERAL TERMS AND CONDITIONS

1. **Legal provisions**

The **competition rules (WB)**, the **legal regulations (RO)**, the **competition licence regulations (WLO)**, the **competition fee regulations (WGO)** and the **anti-doping regulations (ADO)** of the German Swimming Association (DSV) apply in their currently valid version.

For **persons with disabilities** who have the relevant classification certificate, the rules of the **IPC** apply in addition to the **WB** of the German Disabled Sports Association (DBS). Official medication certificates in accordance with **anti-doping regulations** must be kept available. A **valid health certificate**, with a **special exemption** if necessary, must be presented.

All active members of **clubs, departments and starting communities** affiliated with the DSV or **WORLD AQUATICS** are **eligible to participate**. The event has been reported to the SHSV and the DSV.
2. **Licences and sports health**

By **submitting their entries**, the **clubs and starting communities** confirm that the swimmers they have entered:

 - are **eligible to compete for the club/starting group**,
 - the **mandatory annual licence pursuant to Section 19 WB (AT)** for German swimmers has been paid for,
 - they have proven their **fitness for sport by means of a medical certificate** that is no more than **one year old** (§ 11 (2) WB-General Part).

The Flensburger Schwimmklub von 1930 e.V. accepts no liability if it transpires that the **participant is not fit to participate in the sport** or does not have a **valid annual licence**.

3. Swimwear

The **WORLD AQUATICS regulations** and the corresponding **DSV explanations** on swimwear apply. **Visual checks of swimwear** will be carried out before the start.

4. Start rule and timekeeping

The **one-start rule** applies to all competitions. **Electronic timekeeping** will be used.

5. Referees

A smooth running of the competition is only possible with the support of all clubs. Please register a sufficient number of referees, so that we can hold the event as planned. If the number of registered referees is insufficient, the starts of individual clubs may be cancelled.

Each participating club must provide referees who must hold a **valid referee licence** for their respective tasks. The final number of referees to be provided will be announced in the registration results. The **names of the referees** must be sent by email to meldungen@flensburger-schwimm-klub.de by **12:00 noon on 15 February 2026**.

Referees in training should also register with the organiser by **12 noon on 15 February 2026**. The decision on admission will be made by the event referee or referees in the order in which registrations are received.

6. Registrations and data protection

By **submitting the registrations**, the club/starting community acknowledges the **announcement** and declares that it has received a **data protection declaration** from every person involved in the event (active participants, coaches, referees and helpers) – in the case of **minors**, from their **legal guardians**.

Accordingly, the **organiser and event host** is permitted to:

1. To collect, store, process and publish **competition-related, personal data** of the above-mentioned group of persons in **registration results, competition reports and rankings** – including in the context of **reporting on the event**. This data may be forwarded to the **SHSV and the DSV**. The **registration results, minutes and leaderboards** will be published on the internet (e.g. on the **websites of the organiser, the SHSV and the DSV**).
2. To publish **competition-related personal data** as well as **photos, film recordings or photomechanical reproductions** of the participants and to forward them to the **organiser, SHSV, DSV and third parties** (media, social networks, sponsors).
3. To broadcast the entire competition event via **live stream** on the internet, if applicable.

The **data collected includes**: surname, first name, gender, year of birth, performance achieved (placement, time achieved and points scored), any disqualifications with reasons and, if applicable, ENM, club membership and, for referees, their position.

Entries must be submitted on the **DSV entry form (DSV Form 101)** and **DSV entry list (DSV Form 102)**, stating the following information:

- ID number of the athlete
- Year of birth & age group
- Club ID & ID of the regional swimming association

When **registering relay teams**, it is essential to specify the **age groups** and the **names of the relay swimmers**.

- The names of the relay swimmers can be changed on the day of the competition, but the scoring classes cannot.

Entries must be submitted **by email** in a file format that complies with the **DSV or LENEX standard**. Other file formats or handwritten entries **cannot be processed**.

They will also be sent to the participating clubs by email. The competitions will be organised according to age groups based on registration times.
